



ABC 2022 Contractor's Showcase in OKC Exhibitor Form

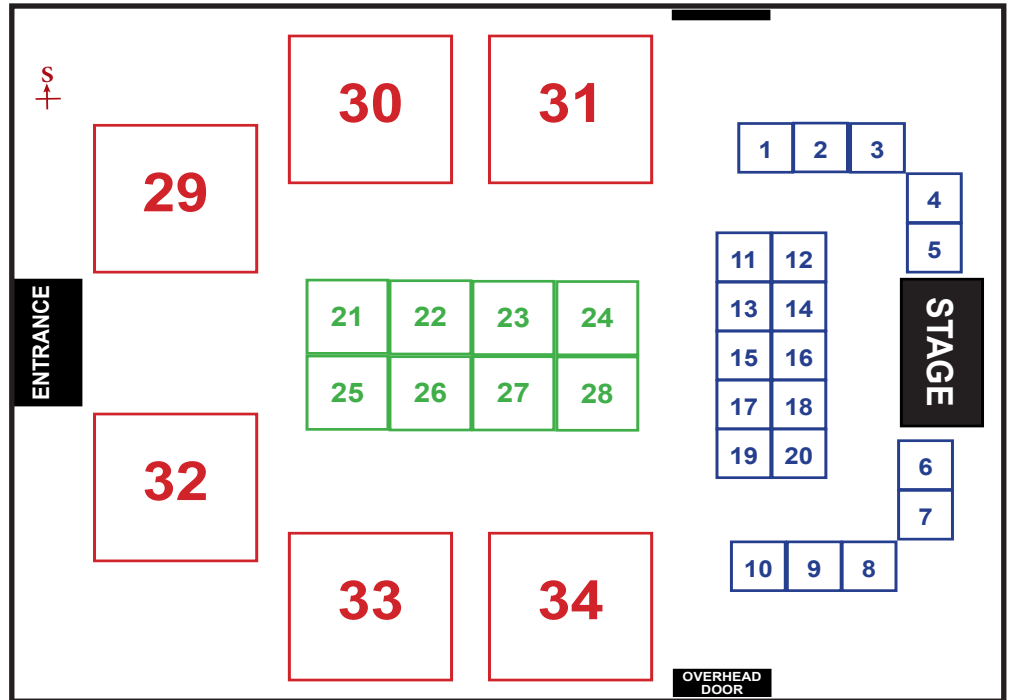

Booth Investment:

10x10 booth (1-20) / \$400 ABC member / \$750 non-member (starting July 21)

15x15 booth (21-28) / \$600 ABC member / \$1,000 non-member (starting July 21)

30x30 vehicle & equipment (29-34) / \$1,000 ABC member / \$1,500 non-member (starting July 21)

Booth Space: All booths are first come first served. Booths are 10x10 and 15x15 for displayers. 30x30 for vehicle and equipment booths. Booth space will include 2 entry tickets for 10x10 and 15x15 booths / 4 entry tickets for 30x30 booths, 1 table and 2 chairs along with pipe and drape dividers. Electricity is \$25 per booth and MUST be ordered ahead of time, extension cords are not provided.

Setup: 30x30 booths will be staged in on August 17th (1pm to 5pm). All 10x10 and 15x15 booths can begin setup at 8am on August 18th (unless prior arrangements for August 17th have been made with ABC) and must be set up by 1pm. Tear down is immediately after Showcase. Vehicles and equipment must be out of the Oklahoma Expo Hall by Friday, August 19th at 10am.

Drawings from the Stage: Limited to drawings for prized valued at \$250 and up.

Booth Specs: ABC must have the following information when you reserve a booth

- Do you need electricity for your booth?
- Do you need entrance from an overhead door?
- Will you display Vehicles or Equipment?

If yes, see OKC Fire Dept restrictions below...

OKC Fire Department restrictions for all liquid or gas-fueled vehicle or equipment displays.

- 1) Maximum fuel allowed 1/4 of a tank or 5 gallons whichever is less. 2) All gas covers shall be taped or have a locking type gas cap. 3) Battery cables shall be disconnected and taped. 4) Vehicles with no fuel gauge or with broken fuel gauge shall not be allowed on the event floor and shall not be displayed, unless the Fire Marshal's Office gives prior written approval.
